Are there services covered before you meet your deductible ?	Yes. Preventive Care . For more information see below. What is the out-of-pocket limit for this plan ?	\$900/person for In- Network Providers . \$1,300/person for Non- Network Providers .	The out-of-pocket limit is the most you could pay in a year for covered services. If you have other family members in this plan , they have to meet their own out-of-pocket limits until the overall family out-of-pocket limit has been met.
